#### Call to Order

Kaitlin Emrich shared her concerns with masking for the elementary kids, her own kids and expressed how effective masking is.

Jacob Dudley shared he is against mandating masks at school due to health concerns.

Lance Lillibridge shared he is against mask mandating due to mental illness.

Valerie Bearbower shared she is against the mask mandate due to not being able to see others' expressions and if vaccinated should not have to wear one.

Maggie Mangold shared her reasons for supporting k-12 masking.

Heather Walker shared she is against the mask mandate due to depression and believes it is the parent's choice.

Braxton Morrison shared his concerns regarding masking following science and controversial data.

Joe Mullino shared his concerns with mask choice due to types, layers, kind, design and how they must fit tightly. Masks should be an option and if not handled correctly do not work.

Scott Barron shared his research back to 1946 on masks and has given the board a file to review. He is concerned with mental health and how educational learning is critical in kindergarten through 3rd grade.

Sara Gill shared she is against masking due to depression, anxieties, and asthma. She believes that others should have a choice in wearing masks.

**1085.** It was moved by Van Steenhuyse and seconded by Fish to request allowable growth and supplemental state aid for the negative special education balance for the 2020-21 year in the amount of \$939,931.27. Motion carried 7/0.

**1086**. It was moved by Fish and seconded by Timmermans to conduct the CatchLife30 Wellness Challenge as recommended by the district Wellness Committee. Motion carried 7/0.
